WARNING: This product contains and/or generates chemicals known to the state of California to cause cancer or birth defects or other reproductive harm.

IMPORTANT: Read this owner's manual carefully and completely before trying to assemble, operate or service this heater. Improper use of this heater can cause serious injury or death from burns, fire, explosion, electrical shock and carbon monoxide poisoning.

A DANGER: Carbon monoxide poisoning may lead to death!

Carbon Monoxide Poisoning: Early signs of carbon monoxide poisoning resemble the flu, with headaches, dizziness or nausea. If you have these signs, the heater may not be working properly. **Get fresh air at once!** Have heater serviced. Some people are more affected by carbon monoxide than others. These include pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol and those at high altitudes.

Natural and Propane/LP Gas: Natural and propane/LP gases are odorless. An odor-making agent is added to the gas. The odor helps you detect a gas leak. However, the odor added to the gas can fade. Gas may be present even though no odor exists.

Make certain you read and understand all warnings. Keep this manual for reference. It is your guide to safe and proper operation of this heater.

WARNING: Any change to this heater or its controls can be dangerous.

WARNING: Do not use a blower insert, heat exchanger insert or other accessory not approved for use with this heater.

WARNING: Do not allow fans to blow directly into the fireplace. Avoid any drafts that alter burner flame patterns. Ceiling fans can create drafts that alter burner flame patterns. Altered burner patterns can cause sooting.

Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.

Do not place clothing or other flammable material on or near the appliance. Never place any objects on the heater.

Fireplace front becomes very hot when running fireplace. Keep children and adults away from hot surfaces to avoid burns or clothing ignition. Fireplace will remain hot for a time after shutdown. Allow surfaces to cool before touching.

Carefully supervise young children when they are in the room with fireplace. When using the optional hand-held remote accessory, keep selector switch inside firebox in the OFF position to prevent children from turning on burners with remote.

Keep the appliance area clear and free from combustible materials, gasoline and other flammable vapors and liquids.

SAFETY INFORMATION Continued

- 1. This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases.
- 2. Do not place propane/LP supply tank(s) inside any structure. Locate propane/LP supply tank(s) outdoors (propane/LP units only).
- 3. If you smell gas
 - shut off gas supply
 - do not try to light any appliance
 - do not touch any electrical switch; do not use any phone in your building
 - immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions
 - if you cannot reach your gas supplier, call the fire department
- 4. This fireplace shall not be installed in a bedroom or bathroom. Do not use this fireplace as a wood-burning fireplace.
- 5. Children and adults should be alerted to the hazards of high surface temperatures and should stay away to avoid burns or clothing ignition.

Keep the appliance area clear and free from combustible materials, gasoline and other flammable vapors and liquids.

- 6. To prevent the creation of soot, follow the instructions in *Cleaning and Maintenance* section.
- 7. Before using furniture polish, wax, carpet cleaner or similar products, turn heater off. If heated, the vapors from these products may create a white powder residue within burner box or on adjacent walls or furniture.
- 8. Do not run fireplace
 - where flammable liquids or vapors are used or stored
 - under dusty conditions
- 9. Do not use this fireplace to cook food or burn paper or other objects.
- 10. Do not use fireplace if any part has been exposed to or under water. Immediately call a qualified service technician to inspect the fireplace and to replace any part of the control system and any gas control which has been under water.



- Turnfireplaceoffandletcoolbeforeservicing. Only a qualified service person should service and repair fireplace.
- 12. Operating fireplace above elevations of 4,500 feet could cause pilot outage.
- 13. To prevent performance problems in propane/LP units, do not use propane/LP fuel tanks of less than 100 lbs. capacity (propane/LP units only).
- 14. Provide adequate clearances around air openings.

Install and use fireplace with care. When an appliance is for connection to a fixed piping system, the installation must conform with local codes, or in the absence of local codes, with *The National Fuel Gas Code ANSI Z223.1/NFPA 54**, *International Fuel Gas Code, Natural Gas and Propane Installation Code, CSA B149.1, or Propane Storage and Handling Code, B149.2, as applicable.*





INSTALLING GAS PIPING TO FIREPLACE LOCATION

WARNING: This appliance requires a 1/2" NPT (National Pipe Thread) inlet connection to the pressure regulator.


A WARNING: A qualified service person must connect fireplace to gas supply. Follow all local codes.

A CAUTION: Never connect propane/LP fireplace directly to the propane/LP supply. This fireplace requires an external regulator (not supplied). Install the external regulator between the fireplace and propane/LP supply.

IMPORTANT: Allow for a minimum space of 1/2" x 26" for air flow to the front louvers of the fireplace from below when covering the face.

NOTICE: Surface temperatures of adjacent walls and mantels become hot during operation. Walls and mantels above the firebox may become hot to the touch. If installed properly, these temperatures meet the requirement of the national product standard. Follow all minimum clearances shown in this manual.


LOCATING YOUR OUTDOOR GAS FIREPLACE



- 1) When selecting a location for your fireplace, ensure that the clearances are met.
- 2) This appliance must be installed in an open-air situation with natural ventilation, without stagnant areas, where gas leakage and products of combustion are rapidly dispersed by wind and natural convection.
- 3) Certain materials or items, when placed under or near the appliance, will be subjected to radiant heat and could become damaged.
- 4) Typically an outdoor space is not enclosed but, any enclosure in which the appliance is used shall comply with one of the following:


An enclosure with walls on all sides, but at least one permanent opening at ground level and no overhead cover.

Within a partial enclosure that includes an overhead cover and no more that two walls.



Within a partial enclosure that includes an overhead cover and more than two walls, the following shall apply:


- At least 25% of the total wall area is completely open, and
- At least 30% of the remaining wall area is open and unrestricted




MANTEL CLEARANCES

NOTE: The combustible area above the facing must not protrude more than ³/₄" from the facing. If it does, it is considered a mantel and must meet the mantel requirements listed in this manual.




Figure 1.1 - Installation of facing materials (Case #1)





Figure 1.2 - Installation of facing materials (Case #2)




Figure 1.3 - Installation of facing materials (Case #3)

ELECTRICAL WIRING

This fireplace requires 110V AC electrical supply for normal operation in order to power up 7V DC adapter which is required to operate Remote Control. However, during power outage situation, its electronic system (DFC board) can be temporarily powered with 6V DC battery pack (4 AA batteries).

WARNING

Electrical connections should only be performed by a qualified, licensed electrician. Main power must be off when connecting to main electrical power supply or performing service. All wiring shall be in compliance with all local, city, and state codes. The appliance, when installed, must be electrically grounded in accordance with local codes, or in the absence of local codes, with the *National Electrical Code ANSI/ NFPA 70 (latest edition)* and *Canadian Electrical Code, CSA C22.1.*

CAUTION

Label all wires before disconnecting when servicing controls. Wiring errors can cause improper and dangerous operation.

INSTALLATION

Continued

WARNING: Never connect natural gas fireplace to private (non-utility) gas wells. This gas is commonly known as wellhead gas.

Installation Items Needed


Before installing fireplace, make sure you have the items listed below.

- external regulator for propane/LP unit only (supplied by installer)
- piping (check local codes)
- sealant (resistant to propane/LP gas)
- equipment shutoff valve *
- test gauge connection *
- sediment trap (optional)
- tee joint
- pipe wrench
- approved flexible gas line with gas connector (if allowed by local codes) (not provided)

A CSA design-certified equipment shutoff valve with 1/8" NPT tap is an acceptable alternative to test gauge connection. Purchase the optional CSA design-certified equipment shutoff valve from your dealer.

For propane/LP units, the installer must supply an external regulator. The external regulator will reduce incoming gas pressure. You must reduce incoming gas pressure to between 11 and 14 inches of water. If you do not reduce incoming gas pressure, heater regulator damage could occur. Install external regulator with the vent pointing down as shown in Figure 3. Pointing the vent down protects it from freezing rain or sleet.





CAUTION: Use only new, black iron or steel pipe. Internally-tinned copper tubing may be used in certain areas. Check your local codes. Use pipe of 1/2" diameter or greater to allow proper gas volume to fireplace. If pipe is too small, undue loss of volume will occur.

Installation must include an equipment shutoff valve, union and plugged 1/8" NPT tap. Locate NPT tap within reach for test gauge hook up. NPT tap must be upstream from fireplace.

SHUTOFF VALVE

IMPORTANT: Install equipment shutoff valve in an accessible location. The equipment shutoff valve is for turning on or shutting off the gas to the appliance.

Check your building codes for any special requirements for locating equipment shutoff valve to fireplaces.

Apply pipe joint sealant lightly to male NPT threads. This will prevent excess sealant from going into pipe. Excess sealant in pipe could result in clogged fireplace valves. Never use sealant on flare threads.




Figure 4 - Gas Connection

INSTALLATION

Continued

WARNING: Use pipe joint sealant that is resistant to liquid petroleum (LP) gas.

We recommend that you install a sediment trap in supply line as shown in Figure 4, page 15. Locate sediment trap where it is within reach for cleaning. Install in piping system between fuel supply and fireplace. Locate sediment trap where trapped matter is not likely to freeze. A sediment trap traps moisture and contaminants. This keeps them from going into fireplace gas controls. If sediment trap is not installed or is installed wrong, fireplace may not run properly.

CONNECTING FIREPLACE TO GAS SUPPLY

- 1. Remove access panel.
- 2. Route gas line (provided by installer) from equipment shutoff valve to fireplace. Route flexible gas supply line through one of the access holes.





Figure 5 - Attaching Flexible Gas Lines Together

- 3. Attach the flexible gas line to gas supply as per Figure 5. Check tightness of flexible gas line attached to gas regulator of fireplace and check all gas connections for leaks.

NOTICE: Most building codes do not permit concealed gas connections. A flexible gas line is provided to allow accessibility from the fireplace (see Figure 5). The flexible gas supply line connection to the equipment shutoff valve should be accessible.

CHECKING GAS PRESSURE

- 1. Check gas type. The gas supply must be the same as stated on the appliance's rating decal. If the gas supply is different from the fireplace, STOP! Do not install the appliance. Contact your dealer immediately.
- 2. To ease installation, a 24" flex line with manual shut-off valve has been provided with on this appliance. Install and attach 1/2" gas line onto shut-off valve.
- 3. After completing gas line connection, purge air from gas line and test all gas joints from the gas meter to the fireplace for leaks. Use a solution of 50/50 water and soap or a gas sniffer.
- 4. To check g as pressures at the valve, turn captured screw counter clockwise 2 or 3 turns and then place tubing to pressure gauge over test point. Turn unit ON.

After taking pressure reading, be sure and turn captured screw clockwise firmly to reseal. Do not over torque. Check test points for gas leaks!



WARNING

Do not use open flame to check for gas leaks.

INSTALLATION

Continued

CHECKING GAS CONNECTIONS

WARNING: Test all gas piping and connections, internal and external to unit, for leaks after installing or servicing. Correct all leaks at once.

WARNING: Never use an open flame to check for a leak. Apply a noncorrosive leak detection fluid to all joints. Bubbles forming show a leak. Correct all leaks at once.

A CAUTION: Make sure external regulator has been installed between propane/LP supply and fireplace. See guidelines under *Connecting Fireplace to Gas Supply*.

PRESSURE TESTING GAS SUPPLY PIPING SYSTEM

Test Pressures In Excess Of 1/2 PSIG (3.5 kPa)

- 1. Disconnect fireplace with its main gas valve (control valve) and equipment shutoff valve from gas supply piping system. Pressures in excess of 1/2 psig will damage fireplace regulator.
- 2. Cap off open end of gas pipe where equipment shutoff valve was connected.
- 3. Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas or opening main gas valve located on or near gas meter for natural gas or using compressed air.
- 4. Check all joints of gas supply piping system. Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak.
- 5. Correct all leaks at once.
- 6. Reconnect fireplace and equipment shutoff valve to gas supply. Check reconnected fittings for leaks.

Test Pressures Equal To or Less Than 1/2 PSIG (3.5 kPa)




Figure 6 - Equipment Shutoff Valve

- 1. Close equipment shutoff valve (see Figure 6).
- 2. Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas or opening main gas valve located on or near gas meter for natural gas or using compressed air.
- 3. Check all joints from gas meter to equipment shutoff valve for natural gas or propane/LP supply to equipment shutoff valve for propane/ LP.Apply noncorrosive leak detection fluid to all joints. Bubbles forming shows a leak.

PRESSURE TESTING FIREPLACE GAS CONNECTIONS

- 1. Open equipment shut off valve
- 2. Open main gas valve located on or near gas meter for natural gas or open propane/LP supply tank valve.

- 3. Make sure control knob of fireplace is in the OFF position.
- 4. Check all joints from equipment shutoff valve to gas control valve. Apply non-corrosive leak detection fluid to all joints. Bubbles forming detects leak.
- 5. Correct all leaks at once.
- 6. Light fireplace (see *Operating Fireplace*, page 19). Check all other internal joints for leaks.
- 7. Turn off fireplace (see To Turn Off Gas to Appliance).

GLASS MEDIA AND LOG SET PLACEMENT

WARNING

Do not operate the appliance without the burner being completely filled with glass media. Lighting the burner without the glass media will cause unsafe temperatures within the appliance.

1. Remove protective film from the firebox and pans. Inspect the interior of the fireplace for any defects.

Please note, that minor scratches and/or finger prints can not be considered as a manufacturer defect.

NOTE: Verify remote control operation prior to placing the glass media and the grate.

- Fill the tray with supplied glass media completely covering the burner as shown. Avoid blocking pilot flame. When finished, test the functionality of the fireplace and its remote control. Remove the front tray if needed.
- 3. Replace the front tray and fill the rest of supplied glass media over the front tray as shown.

Install the grate in the firebox and place the ceramic logs on the grate starting with the larger ones as shown in the photograph.

NOTE: Refer to page 28 for the log identification and proper placement.

4. Secure the smaller logs on top of the large ones. Your fireplace is ready for operation.









LIGHTING INSTRUCTION

FOR YOUR SAFETY READ BEFORE OPERATING

WARNING: If you do not follow these instructions exactly, a fire or explosion may result causing property damage, personal injury, or loss of life.

- A. This appliance is equipped with an ignition device which automatically lights the pilot. Do <u>not</u> try to light the pilot by hand.
- B. BEFORE OPERATING smell all around the appliance area for gas. Be sure to smell next to the floor because some gas is heavier than air and will settle on the floor.

WHAT TO DO IF YOU SMELL GAS

- Do not try to light any appliance.
- Do not touch any electric switch.
- Do not use any phone in your building.
 Immediately call your gas supplier from a neighbor's
- phone. Follow the gas supplier's instructions.
 If you cannot reach your gas supplier, call the fire
- department.
- C. Main gas valve in this appliance is not serviceable and does not have any control knobs or switches to operate. Do not remove heat shields covering the valve and electronic devices; do not try to repair or modify the valve as it may result in a fire or explosion. Call a qualified service technician if you have any safety concerns.
- D. Do not use this appliance if any part of it has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.

LIGHTING FOR THE FIRST TIME



DANGER: Never use an open flame to check for gas leak.

INITIAL LIGHTING

Purge air from the supply line as follows:

- Open main shutoff valve.
- Unscrew main pressure test point.
- · Leave inlet test screw open until gas comes in.
- · When gas is flowing, tighten inlet screw immediately.

LEAK TESTING

- Follow the pipe from the gas supply line connection to the gas valve. Check connection for leaks with soap and water mixture.
- Next check for gas leaks at the burner with soap and water mixture.
- 3. Check the pilot for gas leaks with soap and water mixture.

APPROVED LEAK TESTING METHOD

You may check for gas leaks with the following methods only:

- Soap and water solution
- An approved lead testing spray
- Electronic sniffer

WARNING: If using a soap and water solution to test for leaks, DO NOT spray solution onto electronic parts.



NOTE: Remove any excessive pipe compound from the connections. Excessive pipe compound can set off electronic sniffers.

Check for gas leaks in each of the following locations:


- Pipe from the gas supply line connection to the gas valve
 Burner connections pilot
- Burner connections, pilot
- All joints on valve and control body
 Field media joints (nos shuteff using
- Field made joints / gas shutoff valve
- Factory made joints, each joint and connection

TO TURN OFF GAS TO APPLIANCE

- 1. Turn off all electric power to the appliance if service is to be performed. Unplug 7V DC adapter from the power outlet.
- If necessary, remove access panel from the appliance to access manual shutoff valve on gas line.
- 3. Open access panel. Turn the manual gas shutoff valve clockwise to the full OFF position.
- 4. If necessary, replace Access Panel.



- 1. STOP! Read the safety information on the previous page.
- 2. Turn off all electric power to the appliance.
- 3. Do not attempt to light the pilot by hand.
- 4. Open access panel. (See Illustrated Parts List in Owner's Manual).
- Turn the gas control manual valve clockwise to the full OFF position.
- Wait five (5) minutes to clear out any gas. Then smell for gas, including near the floor. If you smell gas, Stop! Follow "B" in the safety information If you don't smell gas, go to the next step.
- Turn the gas control manual valve counterclockwise to the ON position.
- 8. Plug supplied 7V DC adapter into 110V power outlet.
- 9. Connect the wire to the DC input plug at the unit.
- 10. Turn on all electric power to the appliance.
- 11. Locate Remote Receiver inside of the unit (see Illustrated Parts List). Make sure that the slider switch of the Receiver is in "REMOTE" (middle) position.



- 12. Close access panel.
- 13. Read and follow instructions in how to set up and to use remote control described in supplied "Use and Installation Instructions for the Remote Control".
- 14. If the appliance will not operate, follow the instructions "To Turn Off Gas To Appliance" and call your service technician or gas supplier.

INSPECTING BURNERS

Check pilot flame pattern and burner flame patterns often.

PILOT FLAME PATTERN

Figure 7 shows a correct pilot flame.

The incorrect pilot flame is not touching the flame sensor. This will cause the flame sensor to cool. When the flame sensor cools, the fireplace will shut down.



Figure 7 - Correct Pilot Flame Pattern

If pilot flame pattern is incorrect.

- turn fireplace off (see *To Turn Off Gas to Appliance*, page. 19).
- see *Troubleshooting*, page 22

Note: The correct pilot flame on natural gas units will have a slight curve, but flame should be blue and have no yellow or orange color.

MAIN BURNER

Periodically inspect all burner flame holes with the heater running.

Some burner flame holes may become blocked by debris or rust, with no flame present. If so, turn off heater and let cool. Remove blockage. Blocked burner flame holes may create soot.

IMPORTANT!

If it is evident that the burner is damaged, the burner must be replaced prior to appliance being put into operation. Please refer to Illustrated Parts List when you order a replacement burner.

FRONT BURNER FLAME PATTERN

Figure 8 shows correct burner flame pattern with patern with yellow flame tips and blue base.



Figure 8 - Correct Burner Flame Pattern

Figure 9 shows incorrect flame pattern. The incorrect burner flame pattern shows lazy orange flame.

If burner flame pattern is incorrect as shown in Figure 9:

- turn fireplace off (see *To Turn Off Gas to Appliance*).
- see *Troubleshooting*, page 22.

CLEANING AND MAINTENANCE

WARNING: Turn off fireplace and let cool before cleaning.

A CAUTION: You must keep control areas, burner and circulating air passageways of fireplace clean. Inspect these areas of fireplace before each use. Have fireplace inspected yearly by a qualified service person. Fireplace may need more frequent cleaning due to excessive lint from carpeting, bedding material, pet hair, etc.

WARNING: Failure to keep the primary air opening of the burner clean may result in sooting and property damage.

AIR MIXER/ INJECTOR (LP MODELS) AND PILOT

The primary air inlet holes allow the proper amount of air to mix with the gas. This provides a clean burning flame. Keep these holes clear of dust, dirt, lint and pet hair. Clean these air inlet holes prior to each heating season. Blocked air holes will create soot. We recommend that you clean the unit every three months during operation and have heater inspected yearly by a qualified service person.

We also recommend that you keep the burner tube and pilot assembly clean and free of dust and dirt. To clean these parts we recommend using compressed air no greater than 30 PSI. Your local computer store, hardware store or home center may carry compressed air in a can. You can use a vacuum cleaner in the blow position. If using compressed air in a can, please follow the directions on the can. If you don't follow directions on the can, you could damage the pilot assembly.

- 1. Shut off the unit, including the pilot. Allow the unit to cool for at least thirty minutes.
- 2. Check the air injector located at the end of the burner tube. Remove any large particles of dust, dirt, lint or pet hair with a soft cloth or vacuum cleaner nozzle.

- 3. Blow air into the primary air holes on the injector (see Figure 10).
- 4. In case any large clumps of dust have now been pushed into the burner repeat steps 2 and 3.

Clean the pilot assembly also. A yellow tip on the pilot flame indicates dust and dirt in the pilot assembly.

IMPORTANT!

Any guard or other protective device removed for servicing the appliance shall be replaced prior to operating the appliance.

Installation and repair should be done by aqualified service person. The appliance should be inspected before use and at least annually by a qualified service person. More frequent cleaning may be required as necessary. It is imperative that the control compartment, burners, and circulating air passageways of the appliance are kept clean.

A WARNING: Turn off heater and let cool before servicing. Only a qualified service person should service and repair heater.

A CAUTION: Never use a wire, needle or similar object to clean ODS/pilot. This can damage ODS/pilot unit.

Note: All troubleshooting items are listed in order of operation.

A WARNING: If you smell gas

- Shut off gas supply.
- Do not try to light any appliance.
- Do not touch any electrical switch; do not use any phone in your building.
- Immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions.
- If you cannot reach your gas supplier, call the fire department.

IMPORTANT: Operating fireplace where impurities in air exist may create odors. Cleaning supplies, paint, paint remover, cigarette smoke, cements and glues, new carpet or textiles, etc., create fumes. These fumes may mix with combustion air and create odors. These odors will disappear over time.




Proflame Wiring Diagram



ILLUSTRATED PARTS BREAKDOWN








LOG SET INSTALLATION


ALGONQUIN LOG SET

Woodbridge Fireplace Inc. will also pay for reasonable labor costs incurred in replacing or repairing such components for a period of two years from date of installation.
