SAFETY INFORMATION



WARNINGS

IMPORTANT: The appliance should be inspected before use and at least annually by a quilified service person. More frequent cleaning may be required as necessary. It is imperative that the control compartment, burners and circulating air passageways of the appliance be kept clean.

⚠ DANGER: Carbon monoxide poisoning may lead to death!

Carbon Monoxide Poisoning: 4. Early signs of carbon monoxide poisoning resemble the flu, with headaches, dizziness, or nausea. If you have these signs, the Fire Pit may not be working properly.

Get fresh air at once! Have the Fire Pit serviced. Some people are more affected by carbon monoxide than others. These include pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol, and those at high altitudes.

Natural Gas: Natural gas is odorless. An odor making agent is added to the gas. The odor helps you detect a gas leak. However, 8. the odor added to the gas can fade. Gas may be present even though no odor exists.

Make certain you read and understand all warnings. Keep this

manual for reference. It is your 9. **Do not use appliance if any** guide to safe and proper operation of this appliance. **Do not use appliance if any part has been under water. Immediately call a qualified**

⚠ WARNING: Any change to this appliance or its controls can be dangerous.

- 1. This appliance, as supplied, is only for use with the type of gas indicated on the rating plate.
- 2. When an appliance is for connection to a fixed piping system, the installation must conform with local codes, or in the absence of local codes with the National Fuel Gas Code, ANSI Z223.1/NFPA 54, or International Fuel Gas Code.
- Keep the appliance area clear and free from combustible materials, gasoline and other flammable vapors and liquids.
- 4. Do not burn solid fuel in the fireplace after installing the appliance. Do not use this appliance to cook food or burn paper or other objects.
- 5. Children and adults should be alerted to the hazards of high surface temperatures and should stay away to avoid burns or clothing ignition.
- 6. Clothing or other flammable materials should not be hung from the appliance, or placed on or near the appliance.
- Young children should be carefully supervised when they are in the area of the appliance.
- The appliance, when installed, must be electrically grounded in accordance with local codes or, in the absence of local codes, with the *National Electrical Code*, *ANSI/NFPA 70*.

- Do not use appliance if any part has been under water. Immediately call a qualified service technician to inspect the room appliance and to replace any part of the control system and any gas control which has been under water.
- 10. Inspect the burner before each use of Outdoor Fire Pit.

 The burner must be replaced prior to the appliance being put into operation if it is evident that the burner is damaged.
- 11. Turn the appliance off and let cool before servicing, installling, or repairing. Any guard or other protective device removed for servicing the appliance must be replaced prior to operating the appliance. Only a qualified service person should install, service, or repair appliance.

HIGH ALTITUDE INSTALLATIONS:

The appliance is rated for installations up to 4500' (1372 m) above sea level. Above 4500' the appliance must be derated at the factory for the appropriate altitude.

LOCAL CODES

Install and use Outdoor Fire Pit with care. Follow local codes.

PRODUCT ASSEMBLY

WARNING: Failure to position the parts in accordance with these diagrams or failure to use only parts specially approved with this appliance may result in property damage or personal injury.

- Remove Burner Assembly, and Burner Media from packaging (see Parts List)
- Connect the Burner Assembly to gas supply using supplied flex connector and shutoff valve.
- 3. Evenly fill the media compartment with burner media (broken tempered glass) fully covering the burner as shown on a picture. If you are NOT planning to add optional topping media, then fill the media compartment in full and proceed to the step 5.



4. Place and evenly distribute topping media (optional logs or stones) on top of burner media as shown on a picture.



5. Carefully leak test all connections following the procedure on Page 5.

6. Having free access to the valve light the appliance following the procedure on Page 7.



Make sure the flame is even along the burner and appliance is fully operational and safe for use. Turn OFF the appliance and let it cool.

INSTALLATION

CAUTION: Do not remove the metal data plates attached to the Linear Burner System.

These plates contain important information.

NOTICE: Installation repair should be done by a qualified service person. The appliance should be inspected before use and at least annually by a qualified service person. More frequent cleaning may be required as necessary. It is imperative that control compartment, burner and circulating air passageways of the appliance be kept clean.

CONNECTING TO GAS SUPPLY

MARNING: A qualified service person must connect appliance to gas supply. Follow all local codes.

Installation Items Needed

Before installing the Outdoor Fire Feature, make sure you have all items listed bellow:

- piping (check local codes)
- sealant
- manual shutoff valve
- adjustable (crescent) wrench or pliers
- sediment trap
- tee joints
- pipe wrench

⚠ CAUTION: Use only new, black iron or steel pipe. Internally tinned copper tubing may be used in certain areas. Use pipe of 1/2" diameter or greater to allow proper gas volume to Linear Burner System. If pipe is too small, undue loss of pressure will occur.

Installation must include a manual shutoff valve, union, and plugged 1/8" NPT tap. Locate NPT tap within reach for test gauge hook up. NPT tap must be upstream from the appliance.

Apply pipe joint sealant lightly to male threads. This will prevent excess sealant from going into pipe. Excess sealant in pipe could result in a clogged burner injector.

Install sediment trap in supply line as shown below. Locate sediment trap where it is within reach for cleaning and trapped matter is not likely to freeze. A sediment trap traps moisture and contaminants. This keeps them from going into Outdoor Fire Pit controls.

If sediment trap is not installed or is installed wrong, unit may not run properly.

CHECKING GAS CONNECTION

MARNING: Test all gas piping and connections for leaks after installing or servicing. Correct all leaks at once.


⚠ WARNING: Never use an open flame to check for a leak. Apply a mixture of liquid soap and water on all joints. Bubbles forming show a leak. Correct all leaks at once.

Test Pressures in Excess Of 1/2 psi (3.5 kPa)

The appliance and its individual shutoff valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures in excess of ½ psi (3.5 kPa).


Test Pressures Equal To or Less Than 1/2 psi (3.5 kPa)

The appliance must be isolated from the gas supply piping system by closing its individual manual shutoff valve during any pressure testing of the gas supply piping system at test pressures equal to or less than ½ psi (3.5 kPa).

LIGHTING INSTRUCTION

FOR YOUR SAFETY READ BEFORE LIGHTING

WARNING

If you do not follow these instruction exactly, a fire or explosion may result causing property damage, personal injury or loss of life.

- **A.** This apliance is equiped with a pilot which must be lit by hand while following these instructions exactly.
- **B.** BEFORE OPERATING smell all around the appliance area for gas. Be sure to smell next to the floor because some gas is heavier than air and will settle on the floor.

WHAT TO DO IF YOU SMELL GAS:

- Do not try to light any appliance.
- Do not touch any electric switch; do not use any phone in your building.
- Immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions.
- If you cannot reach your gas supplier, call the fire department.
- **C.** Use only your hand to push in, or turn the gas control knob. Never use tools. If the knob will not push in or turn by hand, don't try to repair it. Call a qualified service technician. Force or attempted repair may result in a fire or explosion.
- **D.** Do not use this appliance if any part of it has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control that has been under water.

LIGHTING PILOT FOR THE FIRST TIME

INITIAL LIGHTING

Purge air from the supply line as follows:

- Open main shutoff valve.
- Unscrew main pressure test point.
- Leave inlet test screw open until gas comes in.
- When gas is flowing, tighten inlet screw immediately.

LEAK TESTING

- 1. Follow the pipe from the gas supply line connection to the gas valve. Check connection for leaks with soap and water mixture.
- 2. Next check for gas leaks at the burner with soap and water mixture.
- 3. Check the pilot for gas leaks with soap and water mixture.

DANGER

Never use an open flame to check for gas leak.

LIGHTING PILOT FOR THE FIRST TIME

APPROVED LEAK TESTING METHOD

You may check for gas leaks with the following methods only:

- Soap and water solution
- An approved leak testing spray
- Electronic sniffer

DANGER

Never use an open flame to check for gas leak.

WARNING

If using a soap and water solution to test for leaks, DO NOT spray solution onto control body.


NOTE: Remove any excessive pipe compound from the connections. Excessive pipe compound can set off electronic sniffers.

Check for gas leaks in each of the following locations:

- Pipe from the gas supply line connection to the gas valve
- Burner connections, pilot
- All joints on valve and control body
- Field made joints / gas shutoff valve
- Factory made joints, each joint and connection

LIGHTING INSTRUCTIONS

- 1. STOP! Read the safety information on previous page.
- 2. Turn the gas control knob to the "OFF" position.
- 3. Wait five (5) minutes to clear out any gas. If you then smell gas, STOP! Follow "B" in the safety information on the previous page. If you don't smell gas, go to the next step.
- 4. Locate the Pilot Assembly on the top surface of the Fire Pit

to "PILOT" position.

6. Depress and turn pilot gas knob counterclockwise imes

7. Depress fully and hold pilot gas knob.

Light pilot with a match or barbeque lighter.

Keep knob fully depressed for a few seconds. Release and check that pilot continues to burn.

- If the pilot does not stay lit, repeat steps 1 and 2.
- If the pilot knob does not pop up when released, STOP and immediately call service technician or gas supplier
- If the pilot will not stay lit after several tries, turn the gas control knob to "OFF" position and call your service technician or gas supplier.



LIGHTING BURNER

Depress and turn the knob counterclockwise to the "ON" position. It will take less than four (4) seconds for the burner to ignite.

CLEANING AND MAINTENANCE

WARNING

Turn off gas before servicing Firepit. It is recommended that a qualified service technician perform these check-ups at the beginning of each heating season.

BURNER

Keep the control clean by vacuuming or brushing at least twice a year. Make sure the burner porting and burner air openings are free of obstructions at all times.

Inspect area around the burner. Remove any lint or foreign material with a brush or vacuum cleaner.

The flame from the burner should be visually checked as soon as the unit is installed and periodically during normal operation.

The burner must be replaced prior to the appliance being put into operation if it is evident that the burner is damaged.



PILOT FLAME

The flames from the pilot should be visually checked as soon as the unit is installed and periodically during normal operation. The pilot flame must always be present when the Fire Pit is in operation. The pilot flame has two distinct flames, one engulfing the flame sensor and the other reaching to the main burner.



After installation, if any of the components manufactured by Woodbridge Fireplace in the appliance are found to be defective in materials or workmanship, Woodbridge Fireplace will, at its option, replace or repair the defective components at no charge to the original owner. Woodbridge Fireplace will also pay for reasonable labor cost incurred in replacing or repairing such components for a period of two years from date of installation. Any products presented for warranty repair must be accompanied by a dated proof of purchase.

This Limited Lifetime Warranty will be void if the appliance is not installed by a qualified installer in accordance with installation instructions. The Limited Lifetime Warranty will also be void if the appliance is not operated and maintained according to the operating instructions supplied with the appliance, and does not extend to (1) firepit burner assembly damaged by accident, neglet, misuse, abuse, alterations, negligence of others, including the installation thereof by unqualified installers, (2) the costs of removal, reinstallation or transportation of defective parts on the appliance, or (3) indentical or consequential damage. All service work must be performed by an authorized service representative.

This warranty is expressly in lieu of other warranties, express or implied, including the warranty of merchantability of fitness for purpose and of all other obligations or liabilities. Woodbridge Fireplace does not assume for it any other obligations or liabilities in connection with sale or use of the appliance. In states that do not allow limitations on how long an implied warranty lasts, or do not allow exclusion of indirect damage, those limitations of exclusions may not apply to you.
